## Terms and Conditions of Membership

**Upon acceptance of my summer membership into The Edgebrook Club, I agree to the following:**

1. I hereby affirm that each named family member resides in my household.
2. To pay the membership fee in full upon application, and to pay in advance all other fees for agreed upon services.
3. To adhere to the rules and policies of the Edgebrook Club, and to use the club facilities in an acceptable and responsible manner.
4. I understand that club facilities may not be available at certain times due to: club activities such as swim meets, emergency maintenance, dangerous weather conditions, etc.
5. To be responsible for any property damage of the club premises by applicant, family members, or guests.
6. In the event of a medical emergency involving myself, my family or guests, I give consent to Edgebrook to provide first aid, and I grant permission to any duly licensed medical personnel and/or medical facility to provide medical care without their incurring liability.
7. Membership is NOT transferable. In situations of relocation, transfer of membership may be possible with Club Manager approval. A \$50.00 administration fee will apply.
8. Prepayments can only be refunded prior to opening day. A \$50.00 administration fee will apply. After opening day, there will be NO refunds.
9. A family membership includes any two adults living at the same residence and all dependent children under the age of 25. Other adults living in the same house are required to have their own membership.
