Upon acceptance of my summer membership into The Edgebrook Club, I agree to the following:

1. I hereby affirm that each named family member resides in my household.
2. To pay in full the membership fee upon application, and to pay in advance all other fees for agreed upon services.
3. To adhere to the rules and policies of the Edgebrook Club, and to use the club facilities in an acceptable and responsible manner.
4. I understand that club facilities may not be available at certain times due to club activities such as swim meets, due to emergency maintenance, or due to dangerous weather conditions, etc.
5. To be responsible for any property damage of the club premises by applicant, family members, or guests.
6. In the event of a medical emergency involving myself, my family or guests, I give consent to Edgebrook to provide first aid, and I grant permission to any duly licensed medical personnel and/or medical facility to provide medical care without their incurring liability.
7. Membership is NOT transferable. In situations of relocation, transfer of membership may be possible with approval of club's Executive Director. A \$50.00 administration fee will apply.
8. Prepayments can only be refunded prior to opening day. A \$50.00 administration fee will apply. After opening day, NO refunds will be issued.

Waiver and Release: Pools are inherently dangerous. In consideration of the use of the pool and club facilities, the member(s) and their guests waive, release and discharge any and all rights and claims for damages against the Edgebrook Club, its Board, its employees, and its members for all claims arising or resulting from use of the pool and club facilities. All members, by signing in and/or by use of the facilities acknowledge that they have informed their guests of the *Waiver and Release*, and the guest(s) agree to the same by use of the club and pool. Parents allowing their children to use the pool, supervised or unsupervised, agree that this waiver and release binds them and their children. This waiver is on-going and applies at all times the pool and club facilities are being used.
