



## JUNIOR TENNIS MEMBERSHIP POLICIES

Our Edgebrook Tennis Staff has developed a strong Junior Tennis Program that we are proud of. We realize that some of our club policies can seem confusing, so please be sure to read this form in its entirety and talk to one of our staff if you have any questions.

### JUNIOR MEMBERSHIP: For school age children under the age of 18

All children enrolled in our junior tennis classes are required to be a member of the club, either as part of a family membership, or with an individual junior tennis membership. Unless siblings are part of a family membership, each child enrolled in the Junior Tennis Program needs to have their own separate junior membership. All Junior Memberships will become inactive September 1<sup>st</sup> following their senior year of High School.

**COST OF JUNIOR MEMBERSHIP:** An administration fee of \$100 + tax, prorated dues for your first month plus a \$150 non-refundable prepayment on account (April through August only) is due upon registration. If you have multiple children in the same household, each child will have their own membership and will pay the administration fee, prorated dues plus prepayment if applicable. There is a full three-month minimum commitment for your Junior Tennis Membership.

**JUNIOR MEMBERSHIP DUES:** Junior Tennis membership dues are currently \$58.54 + tax per month. Dues are charged on the last day of each month for the following month and must be paid monthly in order to keep the membership active, even if the Junior member is not attending the Junior Tennis Program.

**PAYMENT POLICIES:** Dues, program fees and any other charges your child might incur are billed during the current month. Statements are emailed to all members on the first of each month for that previous month's charges plus the current monthly dues. Account balances are due by the 20<sup>th</sup> of each month. A late fee of \$40 will be assessed each month an account is past due.

**MEMBERSHIP CANCELATION:** If you wish to cancel your child's membership after the three-month membership minimum, please notify the club via email to [frontdesk@edgebrookclub.org](mailto:frontdesk@edgebrookclub.org). This cancellation will be effective starting the first day of the following month, or later if you wish. Be aware that canceling your child's participation in the Junior Tennis Program will not cancel their Junior Tennis membership. They will still be a club member and will continue to be billed for the monthly dues until we are informed otherwise. We have many Junior Tennis members who are not in the Junior Tennis Program, but still are members at the club in order to use our courts or book private lessons.

**INACTIVE STATUS:** A Junior membership may only be put on "Inactive" status during the summer months of July and/or August. To inactivate a junior membership, you must notify the club via email to [frontdesk@edgebrookclub.org](mailto:frontdesk@edgebrookclub.org) prior to the month(s) being inactivated. Upon notification, you will be charged a \$35 Inactivation fee. Charges for dues will be stopped as of the first of the month following receipt of the written notice. Dues already billed will not be credited, nor will any portion of the month be prorated. Inactive junior members cannot use the club facilities and will not have any charge privileges. If an inactive junior member, who is not part of a Family Summer membership, participates in any of the junior tennis or swim programs during the inactive period, he or she will automatically be considered active and will be billed retroactively for the full month's dues, and the Inactivation fee will be forfeited.

**MEMBERSHIP REACTIVATION:** Your membership will automatically become active after your Inactive period is complete. If you wish to cancel the membership before September, please see Membership Cancellation on the first page of these policies.

**PRIVATE TENNIS LESSONS:** Private tennis lessons are available upon request with any of our two tennis pros (Sean Kelly, Faiz Khan, & Emahd Kahn). Please contact the pro of your choice to schedule lessons. You can find their contact information on our website. Current rates start at \$88/hour plus tax.

**SUMMER FAMILY MEMBERSHIPS:** Inactive juniors, who are part of a Summer Family Membership, will be entitled to all club privileges enjoyed by the summer members. This, however, does NOT include charge privileges. All summer members must pay cash in advance for all services and concessions.

**SUMMER POOL ACCESS:** Your Junior Tennis Membership does not include access to the pool during the summer months. If you would like to have access to the pool, swim team, swim lessons or other aquatic offerings, add this to your membership by emailing [frontdesk@edgebrookclub.org](mailto:frontdesk@edgebrookclub.org). An aquatics access fee will be billed to your account monthly for June, July and/or August at a rate of \$35 plus tax per month.

**COURT RESERVATIONS:** As a member, your child can reserve a court for open play up to six days in advance. However, reservations for prime-time courts (weekday evenings 7:30 & 9:00 p.m., and weekend mornings 8:00, 9:30, & 11 a.m.) are restricted to being reserved by adults only. Juniors can only reserve prime-time courts, if available, 24 hours or less in advance. We encourage juniors to play with other junior members to practice new stroke mechanics and develop match play skills.

**CANCELLING A COURT:** Please call the office to cancel a reservation if your child is unable to use a court they have reserved. If the cancellation is made less than 24 hours prior to the scheduled court time and if the court is not subsequently utilized, the court fee will be charged to the member who made the reservation. If players do not call to cancel a scheduled court at all, an additional \$18 "no call" charge applies. This policy has been in place for many years in order to minimize unused courts.

**CANCELING PRIVATE LESSONS:** Please call the office as soon as possible to cancel a private lesson if your child is unable to attend. You will also be responsible for contacting the Tennis Pro. If the cancellation is made less than 48 hours prior to the scheduled lesson, or if your child fails to show at the designated time, you will be charged the full lesson fee.

**BILLING FOR COURTS:** Court fees are \$18 for 1½ hour courts, which will be billed to your account. If two or more members are to share the court fee, please make sure your child informs the office when he/she checks in to play so that all players can be billed correctly. If your child has a guest (non-member) playing on the court, the \$22 guest fee will be billed to the Junior Member account.
